2013/14 MID-YEAR BUDGET AND PERFORMANCE ASSESSMENT VISIT

Section 72 of the in full (MFMA) requires the Accounting Officer of a municipality to assess the performance of the municipality for the first half of the financial year. This assessment must be done by 25 January of each year.

Section 72(1)(b) requires the municipality to submit the assessment report to the Executive Mayor of the municipality, the National Treasury and the relevant Provincial Treasury in the province.

In line with the Provincial Treasury's monitoring and oversight responsibilities as enshrined in the Constitution, we advise you of our intention to engage with your municipality during January 2014. The purpose of the engagement is to review your municipality's mid-year performance before the adjustment budget is passed as per Sections 28 and 72(3)(a) of the MFMA. Specifically, the review will focus on, among other things, the following:

- The 2012/13 annual report outcome and key achievements during the period against published targets:
 - Financial outcome against budget;
 - Performance against targets; and
 - Audit opinion by the Auditor General.
- Review of the 2013/14 mid-year results against targets set in the Integrated Development Plan (IDP) and the targets set in the Service Delivery and Budget Implementation Plan (SDBIP). The review will focus on municipal-wide, departmental and line management targets and the alignment of the SDBIP with senior management performance agreements. The review should also be against the background of the second quarterly financial results that should be available by the time of the visits.
- Infrastructure delivery achievements against the Infrastructure Plan of the municipality;
- Spending on all the conditional grants and progress to achieving the conditions. An
 assessment will be made of national and provincial grants as well as grants from other
 organs of state and donor funds;
- The preparation of adjustment budgets and inputs thereto;
- The 2014/15 budget schedule and progress in achieving the milestones and timelines specified in the schedule; and
- The readiness of the Municipality to fully conform to the new budget and reporting regulations, especially the budget formats released by the National Treasury on 27 June 2008.

It will be highly appreciated if you could ensure that your presentation is structured along the areas outlined above and copies of your municipality's presentations are forwarded to us at least 2 working days before the day of the meeting.





The Provincial Treasury regards the budget and performance assessments as a municipal-wide responsibility and, as a consequence, expects your municipality's Heads of Departments and other Section 57 Managers to be part of the engagement.
