ASSETS THAT SHOULD BE INCLUDED IN THE EXCLUSION LIST

During a workshop held at National Treasury on asset management the need to compile a list of "assets" that should be excluded from recording in the Asset Register was identified. These assets would typical be of relatively low value and high volume for example, dustbins, staplers, etc.

We request your assistance in this matter by forwarding the type of items that would be candidates for the list from your department's perspective. Due to the inconsistencies experienced during the audit process it was considered prudent that a provincial list is compiled that would be forwarded to the National Treasury for inclusion in the national list. Departments will then be able to choose appropriate items and include same in their asset management policies.
