REQUEST FOR NOMINATIONS FOR PILOT DELIVERY OF THE SUPPLY CHAIN MANAGEMENT LEARNERSHIP FOR THE LOCAL GOVERNMENT SPHERE

1. PURPOSE

All Municipal Managers in the Mpumalanga Province are hereby requested to submit nominations of two (2) employed officials to enrol on the Supply Chain Management Learnership for the Local Government Sphere in the Province.

2. BACKGROUND

In terms of constitutional mandate, the National Treasury has a responsibility to assist the three spheres of government to build their capacity for sound and transparent financial management. Accordingly, the National Treasury coordinated a broad collaboration process to produce a capacity development strategy for public financial management.

3. DISCUSSION

As part of implementing the strategy, National Treasury engaged the Transport Sector Education and Training Authority (TETA) to support National Treasury supply chain management learning solutions. TETA invited National Treasury to submit a proposal that has been approved by the TETA board to implement a supply chain management learnership solution to grow a cadre of approximately skilled people in supply chain.

The learnership is based on an accredited unit standard-based qualification termed the Higher Certificate: Supply Chain Management (SAQA Qualification ID: 74149) and consists of 152 credits at NQF Level 5 on the South African Qualification Framework (NQF) for the elective stream Purchasing and Supply for the Public Sector.

4. PROVINCIAL TREASURY'S DIRECTIVE TO MUNICIPALITIES

As part of the guidance and participation to ensure that there is an uptake of the project, we would like to direct as follows:

- 4.1 The municipalities are requested to support the initiative by nominating two (2) employed officials that do not have a formal SCM qualification at NQF level 5 to be trained on the programme.
- 4.2 A detailed correspondence from National Treasury is hereby attached for your administration and compliance to the requirement of nominating.

5. DISSEMINATION OF THE INFORMATION

Municipal Managers should disseminate the contents of this Circular to their respective Chief Financial Officers and Supply Chain Management Units in order to accelerate the nomination and submission process.

PILOT DELIVERY OF THE SUPPLY CHAIN MAMAGEMENT LEARNERSHIP FOR THE LOCAL GOVERNMENT SPHERE

- Given its constitutional mandate, the National Treasury (NT) has a responsibility to assist the three spheres of government to build their capacity for sound and transparent financial management. Accordingly, the NT coordinated a broad collaboration to produce a capacity development strategy for public financial management.
- 2. As part of implementing the strategy, National Treasury engaged the Transport Sector Education and Training Authority (TETA) to support National Treasury supply chain management learning solutions. TETA invited NT to submit a proposal that has been approved by the TETA board to implement a supply chain management learnership solution to grow a cadre of appropriately skilled people in supply chain. A letter of funding allocation has been issued to National Treasury as per attached Annexure A to implement the learnership for employed Supply Chain Management practitioners in municipalities.
- 3. The learnership is based on an accredited unit standard-based qualification termed the Higher Certificate: Supply Chain Management (SAQA Qual. ID: 74149), and consists of 152 credits at NQF Level 05 on the South African National Qualification Framework (NQF) for the elective Stream Purchasing and Supply for the Public Sector. The delivery methodology will be outcomes-based via a mentored approach with workplace examples and case studies, group assignments, study groups to work together, and completion of a Portfolio of Evidence (PoE) for each unit standard consisting of a formative and final summative assessment. National Treasury is at this stage supporting the roll out of this learnership programme to municipalities in all the provinces.
- A total number of 20 delegates can be enrolled into the learnership programme.
 The attached brochure as Annexure B outlines the details of the learning programme.

- 5. There is now an opportunity for municipalities to participate in the roll out by identifying employed SCM official that do not have a formal SCM qualification at NQF 5 level to be trained on the programme. Funding has been obtained from TETA to support the roll out. The funding covers payment of learner fees. The intervention will take place in all nine (9) provinces of South Africa, namely, the Western Cape, Eastern Cape, Northern Cape, North West, Gauteng, Limpopo, Mpumalanga, Free State and KwaZulu-Natal. The total number of learners per province will be twenty two (22). The assignment will be executed over a period of 24 months, including pre-delivery (3 months), delivery of contact sessions (18 months), and post-delivery (3 months).
- 6. National Treasury would like to kindly request collaboration with your province to sensitize and recruit employed SCM officials employed in municipalities to be part of this learnership. The details of the nomination process and details of the programme can be discussed with Mr Daniel Mokoena, via emall: Daniel Mokoena@treasury.gov.za, (012) 395 6516. Candidates selection is vital for success of the programme. Potential candidates will undergo a learner selection process consisting of screening, technical and aspirational assessments. The Learner Selection criteria will include: the ability to devote time for 18 months; motivation to remain on the programme (must submit motivational letter); and the

The Provincial Treasury and Municipalities will need to provide support for the learnership process which includes: allowing time out of the office for learners to attend training; assign mentors for the learners; assigning a project administrator to liaise and communicate with learners; assisting with logistical arrangements for the training; assisting with the collection of documentation; keeping record; of late submissions, and collating attendance registers.
