PUBLISHING OF PROVINCIAL TENDER BULLETIN IN FEBRUARY AND MARCH 2018

1. PURPOSE

2. BACKGROUND

In order to ensure uniformity and standardization the Provincial Treasury renders a support service on behalf of all Departments and Public Entities on the printing and publishing of the Provincial Tender Bulletin. This also assists in reducing duplication of efforts, time saving and resource saving in departments and public entities.

3. DISCUSSION

The 2017/18 financial year is almost at the end and in continuing to provide support to Departments and Public Entities the Provincial Treasury will be publishing the last two bulletins during February and March 2018. The bulletins will be printed and issued on Friday, 09 February 2018 and Friday, 09 March 2018 respectively.

All projects to be advertised must be in the institutions' procurement plans. Furthermore, note that outside the dates provided no requests for special bulletins will be entertained.

4. SUBMISSION TIMELINES OF TENDER DOCUMENTS

Therefore, all tenders to be advertised, in line with the institutions' procurement plans, should be submitted to the Provincial Treasury by Thursday, 01 February 2018 and Thursday, 01 March 2018 respectively.

5. DISSEMINATION OF INFORMATION

Heads of Departments and Chief Executive Officers of Public Entities are requested to bring the contents of this Circular to the attention of the Chief Financial Officers and Heads of Supply Chain Management Units for implementation in order to assist with the process.
