CENTRAL SUPPLIER DATABASE (CSD)

1. PURPOSE

This circular is intended to inform departments and public entities listed on schedule 3C to the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999) about National Treasury's single platform, the Central Supplier Database (CSD), for the registration of prospective suppliers including the verification functionality of key supplier information.

2. BACKGROUND

In terms of section 38(1)(a)(iii) and 51(1)(iii) of the PFMA, the accounting officer of a department and accounting authority of a public entity listed in Schedule 3C to the PFMA must ensure that their respective institutions have and maintain an appropriate procurement and provisioning system which is fair, equitable, transparent, competitive and cost effective.

It is also a requirement that, all goods and services procured through quotations, should be sourced from suppliers listed in the institution's prospective supplier database. However, the process of registration and verification of supplier information has not been uniform and standardised for all organs of state, making it difficult to do business with government.

National Treasury decided to establish and administer the CSD as well as facilitating the verification of supplier information on behalf of all departments and public entities listed in schedule 3 of the PFMA to avoid the multiple registrations by prospective suppliers with each organ of state they intend doing business with and the discrepancies resulting from the verification process done by institutions.

To this end, a self-explanatory circular from National Treasury is hereby attached for further management.

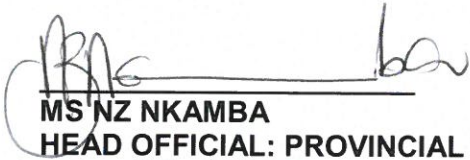
The Auditor-General will be notified of the contents of this circular.
