#### Objective

The objective of this circular is to urge all Provincial Departments in the Mpumalanga Province to utilise Intenda Solution Suite (ISS) system.

#### Background

The Provincial Treasury acquired the electronic procurement system in order to improve accountability, transparency and ensure value for money in the procurement of goods and services. The system is called Intenda Solution Suite (ISS) system which provides the following beneficial services to the Provincial Administration:

- Centralisation of suppliers database
- Rotation of suppliers
- Request for quotations
- Tender evaluation
- Tender adjudication
- Contract Management
- Reports for decision making

## Utilisations of ISS system

ISS system has been implemented in all 12 Provincial Departments in the Provincial Administration. It was, however, of concern that none of the 12 Departments are using the ISS system fully. It has been further noticed that some Departments are using the old version of the system. It must be mentioned that the below action plans are just an emphasis of what the Departments should have done already. The capturing of suppliers should have been done when the ISS system was introduced in 2004 and below is a period for Departments to ensure that all suppliers are captured on ISS system, meaning those that are not captured must be captured.

All the Departments will be upgraded to the new version of ISS system and are urged to do the

The letter must be accompanied by detailed project plan signed by the Accounting Officer stating the following:

- The start date and end date of capturing suppliers on ISS
- Effective date of full utilisation of quotations on ISS
- Effective date of full utilisation of Tendering on ISS
