SUBJECT: NON-AVAILABILITY OF BID DOCUMENTS IN PROVINCIAL TENDER OFFICES

This communiqué serves to inform and register the Provincial Treasury's dissatisfaction in the manner in which the Departments manage the submission of bid documents after bids have been advertised.

The Departments have, on a number of occasions in the 2014/15 financial year, requested the Provincial Treasury to allocate and advertise tenders in the tender bulletin with the agreement that all tender documents required will be made available to our tender offices timeously in the interest of promoting service delivery.

However, in a number of occasions Departments did not submit the necessary documentation and due to this non-submission, the image of the Provincial Treasury and of the Province gets tarnished. This further has negative implications on the bidders for they have to travel to and from tender offices with no documents. Furthermore, when audits are done internally this matter always come under scrutiny and remains an issue of non-compliance.

Therefore, the Provincial Treasury has resolved that henceforth for all bids to be allocated with bid numbers and advertised the required documents must firstly be lodged with the Tender Administration office failure of which no advertisements will be done.
