PLAN TO RECOVER OUTSTANDING OWN REVENUE FROM MUNICIPALITIES

The Province has under collected own revenue during the financial year 2011/2012 by approximately R105 million.

The under-collection was caused by various municipalities which collect revenue on behalf of the Provincial Administration (Motor Vehicle Tax) and municipalities withholding the portion that is due to the Province hence this Circular.

The Accounting Officers will recall that the matter of outstanding revenue from municipalities was raised during the PMC Lekgotla that took place on 5-6 July 2012 with the understanding that follow ups will be made by the Provincial Treasury and Department of Community Safety, Security and Liaison by way of engagements with the affected municipalities.

Subsequent to the PMC meeting, a presentation was made by the Provincial Treasury at the municipal CFO forum that took place in Ermelo on 26^{th} July 2012.
