REQUEST FOR PROGRESS REPORT ON THE IMPLEMENTATION OF SECTION 3 OF NATIONAL TREASURY INSTRUCTION NO 1 OF 2017/2018

PURPOSE

The purpose of this Circular is to request Departments and Public Entities to provide progress on the implementation of section 3 of the National Treasury Instruction No. 1 of 2017/2018.

2. DISCUSSION

National Treasury issued Treasury Instruction No. 1 of 2017/2018 on the transitional arrangements for the Travel Management Services. The transitional arrangement was up to 30 September 2017 with the mandatory implementation that took effect from 1 October 2017 of the National Travel Policy Framework.

Departments and Public Entities are therefore requested to provide progress reports to the National Treasury on the implementation of National Treasury Instruction No. 1 of 2017/2018. The progress report should be submitted to ptgumede@mpg.gov.za by 13 April 2018 as per the attached reporting template. Given the constraint in terms of timeframe provided by National Treasury the same report should be copied to travel.policyreview@treasury.gov.za.

Heads of Departments and Chief Executive Officers of Public Entities are requested to bring the contents of the attached documents from National Treasury to the attention of Chief Financial Officers of institutions for implementation.
