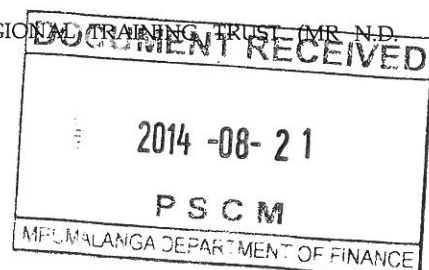

Date : 1 September 2014 to 5 September 2014


Venue : Protea Hotel (Emalahleni)
