1. OBJECTIVE

The objective of this Circular is to invite all Mpumalanga Provincial Government Departments to participate on the approved tender number: MPP002/17/01 for Travel, Accommodation and Related Services for a period of two (2) years.

2. BACKGROUND

Provincial Treasury has advertised the transversal tender for Travel, Accommodation and Related Services in November 2017 and finalised the tender process on 30 March 2018.

Three service providers were appointed to provide Travel, Accommodation and Related Services to Mpumalanga Provincial Government Departments for a period of two years with starting date from 4 April 2018 and expiring date 4 April 2020.

The Service Level Agreement will be signed between Mpumalanga Provincial Treasury and the appointed Service Providers.

You are kindly requested to complete the participation request form attached to this Circular for your Department to be able to participate on the approved tender. Your application must be submitted to Provincial Treasury, Transversal Services, for attention Ms C Ruthven.

All Departments that are currently having standing contracts on Travel and Accommodation must provide their current contract information to Provincial Treasury, Transversal Contract Management section. It is further recommended that all Departments must participate on the approved transversal contract if and when their standing contracts expire.

All Departments who are currently in a process to appoint new service providers and those who are on a month-to-month basis must discontinue the process with immediate effect due to the legislature mandate to implement transversal contracts.
