SAIPA PROGRAMME TO PROFESSIONALISE THE FINANCE PERSONNEL

1. BACKGROUND

The Provincial Treasury has arranged a skills development Programme for the purpose of the Chief Financial Officers and related qualifying finance, audit and risk officials in the Province to become Professional Accountants. The Programme is arranged with the South African Institute of Public Accountants (SAIPA).

SAIPA is the member of International Federation of Accountants (IFAC) and also that of Pan African Federation of Accountants (PAFA).

2. PROGRAMME

The Programme was initiated in 2019 financial year with the objective to:

- Improve the professional competency of finance officials;
- Ensure integration of technical skills with operations;
- Develop a pool of finance officials who will understand to implement government programmes;
- Contribute to the full personal development of finance officials, which leads to social and economic development of the nation at large

All officials in the commercial sector within the Provincial and Local spheres of government are encouraged to participate in the Programme. The Programme runs twice in a year. Online classes are conducted during the week after hours or during weekends.
