REQUEST FOR SUBMISSION OF SERVICE LEVEL AGREEMENTS (SLAs) / CONTRACTS FOR APPOINTED CONSULTANTS

BACKGROUND

195 of South Africa's 284 municipalities spent R454 million on private consultants this past financial year. Though they were predominantly financial management consultants, this spending was over and above the salaries paid to government officials who are employed to fulfil financial management and reporting responsibilities. Out of the 21 municipalities in Mpumalanga 9 used consultants.

Only 1 of the 9 municipalities that used consultants in Municipalities got an unqualified audit during the financial year in question. Four received disclaimer audit opinions and 4 got qualified opinions, meaning that the financial documentation they provided was inadequate and the auditors could not express an opinion.

2. PURPOSE

In order for the Provincial Treasury to assist municipalities to strengthen the future agreements with service providers in order to increase the value received, municipalities are requested to provide information pertaining these contracts.

It will consequently be appreciated if municipalities could submit the following information regarding service providers appointed to assist the Budget and Treasury Office, to Provincial Treasury:

- 1. A schedule indicating the following information:
 - Name of Service Provider
 - Purpose of appointment
 - Appointment date
 - Contract duration
- Copies of Contracts / SLAs for all Consultants appointed from 2012/13 up to 2014/15 financial year (as listed above).
- 3. The Municipality must also indicate planned appointment of new service providers with reasons for service requirements (same schedule as in par. 1 to be submitted).
