- iv. Assesses IPMPs and IPIPs.
- v. Signs off on procurement strategies as included in the IPMPs [requirement for performance grant bid].
- vi. Assesses bids for performance grants.

**b) Infrastructure Performance Improvement**

- i. Enforces quality in the spending of funds.
- ii. Supports Department to develop institutional capacity required for infrastructure performance.
- iii. Monitors adherence to SDAs and reports to Office of the Premier.
- iv. Collects and provides support documentation in terms of any dispute that need to be mediated by the Office of the Premier in terms of non-adherence to the Provincial IDMS, signed Service Deliver Agreements [SDAs], Division of Revenue Act and/or National Treasury Regulations.
- v. Refers matters of dispute or non-adherence on the part of Departments in the terms of the implementation of the signed SDAs to the Office of the Premier.
- vi. Manages the implementation and revision of the IDMS in the Province.
- vii. Ring-fences adequate funding for maintenance of Facilities and/or Offices and/or Roads.
- viii. Takes into consideration life-cycle costs when decisions are taken within the limitations posed in terms of the Medium Term Expenditure Framework [MTEF] budgets.
- ix. Reviews performance and expenditure reports and make recommendations for improvements.
- x. Determines cases where planning time horizons and or requirements for pre-feasibility studies can be deviated from.

**c) Procurement**

- i. Provides inputs to the Chief Procurement Officer in terms of any construction procurement projects.
- ii. Facilitates the implementation of the Standards for Construction Procurement in the Province.
- iii. Validates physical progress of infrastructure projects against expenditure.
- iv. Certifies in collaboration with the Chief Procurement Officer that the appropriate tender processes were followed when tenders for infrastructure projects were awarded. The certification must include adherence to bid specifications and that the selected contractors have adequate capacity to deliver the project in time and within budget.

**d) Monitoring**

- i. Chairs the Provincial Technical Infrastructure Coordinating Committee if the Director General is not available.
- ii. Prepares consolidated provincial quarterly report for presentation to the Provincial Technical Infrastructure Coordinating Committee.
- iii. Conduct site visits.
- iv. Participates in Post Project and Post Occupancy Evaluations.
- v. Reviews projects expenditure and makes recommendations to National Departments on underperforming projects.
