## PROVINCIAL TREASURY CIRCULAR NO. 30 OF 2016

## PREPARATION AND SUBMISSION OF INTERIM FINANCIAL STATEMENTS (IFS)

The Mpumalanga Provincial Treasury is requesting all departments to prepare Interim Financial Statements for the period ending 30 June 2016. An accurate and complete IFS template must be submitted to the Provincial Treasury within 30 days after the end of the period.

In terms of the Instruction Note 1 of 2013/2014 Reporting requirements of the Interim Financial Statement (IFS) will be prepared and submitted on guarterly basis.

National and Provincial departments are required to comply with the IFS instruction schedule for the 2015/16 financial year. The IFS should be submitted after one month of the dates indicated below:

- 30 June 2016 a)
- b) 30 September 2016
- 30 December 2016 c)

The purpose of Interim Financial Statements is to detect and address issues that are a challenge to departments with regard to Annual Financial Statements before year-end, improvement of audit outcomes.

The following should be adhered to by Departments for the process to be effective:

- Proper closure of the books to be done a)
- All suspense accounts should be cleared to zero to enable Departments to provide b) complete financial information on expenditure and revenue
- Stock counts and reconciliation of assets between BAS and LOGIS systems must be c) performed
- Reconciliation of assets, creditors, debtors and bank accounts must be performed d)
- The expenditure management report should be scrutinized to ensure that all expenditure e) is correctly allocated to the budget appropriated
