QUARTELY REPORTING REQUIREMENTS ON THE EXPENDITURE FOR THE TRAVEL AND ACCOMMODATION TRANSVERSAL CONTRACT

1. OBJECTIVE

The objective of this Circular is to request all participating Government Departments in the Travel and Accommodation transversal contract to provide the Provincial Treasury with all expenditure and outstanding payments for services rendered by the appointed service providers on a quarterly basis.

2. BACKGROUND

The Provincial Treasury has established the Transversal Contracts Unit to coordinate; implement, monitor and evaluate all Provincial specific Transversal contracts within the Mpumalanga Provincial Administration.

3. UTILISATION OF THE SRVICE PROVIDERS

A Travel and Accommodation transversal contract has been awarded to three service providers; namely:

- a) Vakasha Travel,
- b) City of Choice and
- c) ZAPG Travel and Tours

It would be expected that each participating Department should contract all the three (3) service providers and endeavour to utilise them equally such that there is no service provider preferred over the other. The possible equal distribution of services should be ensured to avoid Irregular Expenditure.

4. MONITORING OF THE CONTRACTS

Each participating Department should provide the Provincial Treasury with the expenditure reports per service provider and any outstanding amount for all services rendered on quarterly basis. The reporting template will be forwarded to each Department to populate the information for easy monitoring.

The reporting template will require information on the following:

- a) Total value paid to each service provider
- b) Total value outstanding to be paid
- c) Challenges and proposed solutions

The reports should be submitted to the Provincial Treasury fifteen (15) days after the end of the quarter.
