SUBMISSION OF THE MARCH 2017/18 PRE-AUDITED IN-YEAR MANAGEMENT, MONITORING AND REPORTING (IYM) MODEL

In terms of Section 40(1)(c) of the Public Finance Management Act (PFMA), No. 1 of 1999, Departments are required to submit the Annual Financial Statements (AFS) to the Auditor-General for auditing AND the relevant Treasury within two months after the end of the financial year.

In relation to the above, Departments are requested to submit to the Provincial Treasury, an updated March 2017/18 In-Year Management Monitoring and Reporting (IYM) Model to reflect a mirror image of the Pre-audited AFS on or before Tuesday, 5 June 2018.

The Provincial Treasury intends to again compare the numbers reflected in the Pre-Audited AFS with the numbers reflected on BAS as well as with the pre-audited budget outcome (as at 31 March 2018) reported by Departments in the In-year Management, Monitoring and Reporting System (IYM). This comparison will be done per Department and per economic classification. The purpose of the exercise is to determine the extent of variances that exist between the AFS, BAS and IYM numbers.
