COLLECTED OWN REVENUE TO BE TRANSFERRED INTO PROVINCIAL REVENUE FUND

OBJECTIVE

The objective of this Circular is to remind all Departments to transfer all collected own revenue into the Provincial Revenue Fund for the month in which revenue has been collected.

BACKGROUND

The Provincial Treasury has the mandate to ensure that all Departments collect and transfer collected revenue into the Provincial Revenue Fund in terms of Section 21(1)(a) and Section 22 of the Public Finance Management Act, No. 1 of 1999.

It has come to the attention of the Provincial Treasury that some Departments are not transferring collected revenue into the Revenue Fund regularly as prescribed in the Public Finance Management Act, they keep collected revenue in suspense accounts. Departments are advised to refrain from keeping revenue in their suspense accounts. Unallocated revenues should be resolved on monthly basis and transferred to the Provincial Treasury as per the Revenue Transfer Schedule.
