#### SUBJECT: FET COLLEGES BAS RE-IMPLEMENTATIONS

#### 1. PURPOSE

1.1. The purpose of this circular is to arrange a meeting with FET Colleges in order to get clarity as to whether their Basic Accounting System (BAS) will be continued taking into consideration the re-implemented of changes in Standard Chart Of Accounts (SCOA) with effect from 01 April 2013.

#### 2. BACKGROUND

- 2.1. Provincial Treasury has a responsibility of providing support and monitor the transversal systems.
- 2.2. Persal and BAS was implemented in 2009 to the three FET Colleges
- 2.3. BAS is not being used at all by Ehlanzeni FET College and Nkangala FET College while Gert Sibande FET College uses it to its minimum.
- 2.4. Persal is being used by the three FET Colleges.

#### 3 IMPLICATIONS

The none use and minimum use of BAS by the FET Colleges has a negative impact on reporting as Persal interfaces into BAS and if those interfaces are not resolved then proper reporting is impaired. BAS also serves as a link between Persal and the Bank and provide a ledger account and if it has to be de-implemented then the FET Colleges will need to implement a system that will serve the very same purpose for Persal to function.
