## **ESTALISHMENT OF THE ANTI- FRAUD AND CORRUPTION COMMITTEES:**

This circular is issued to request all Municipalities to establish the Anti-Fraud and Corruption Committees. As part of the Enterprise Risk management, Accounting Officers are responsible for establishing structures to address the threat of fraud within their respective institutions. The size of the institution can be used to decide whether to have a separate oversight committee or to use the Risk management Committee as an oversight body.

The Anti-Fraud and Corruption Committee is responsible for overseeing the Institution's approach to fraud prevention, fraud detection strategies and response to fraud and corruption incidents reported by employees or other external parties and should be chaired by an independent chairperson. The various business divisions should have representation on this committee. The Internal Auditor shall be a compulsory member.

Municipalities are encouraged to establish Anti-Fraud and Corruption Committees to effectively respond to issues of Fraud and Corruption before the end of the first quarter (30 September 2015) and furthermore ensure the development of the Anti-Fraud and Corruption enabling documents including the documentation of the risks relating to Fraud and corruption.
