PREPARATION AND SUBMISSION OF THE 2012/13 AUDIT ACTION PLANS TO ADDRESS ISSUES RAISED BY THE AUDITOR GENERAL

The above subject-matter refers.

Section 131 of the Municipal Finance Management Act, No. 56 of 2003, requires municipalities to address issues raised by the Auditor General in the audit report.

The Provincial Treasury, in terms of Section 5(4) (i) & (iv) is obligated by the Act to monitor compliance with the Act and monitor the submission of reports by municipalities.

It is in light of the above legislative requirements, that your municipality is requested to prepare the 2012/13 audit action plans, immediately after receipt of your audit report from the Auditor General.

It should be noted that a resolution was taken on 15 August 2013 during the MUNIMEC meeting held at Gert Sibande District Council Chamber in Ermelo and it was further reiterated on 27 August 2013 during the Premier's Coordinating Forum (PCF) Lekgotla that all municipalities who have received their audit reports by the end of November should develop and submit audit action plans for the 2012/13 audit prior to the recess (before 15 December 2013).

The current practice is that municipalities only develop the audit action plans during February each year and therefore only have four months (March- June) to address the issues raised which has proven not to be sufficient to resolve all issues on time.

Therefore based on the above practice the Provincial Treasury intend assisting municipalities as early as January 2014, to implement and monitor the audit action plans as this will allow a period of six months (January-June) to assist municipalities in addressing the audit findings.

The Provincial Treasury is committed to assist municipalities in addressing the audit findings as dedicated support teams consisting of officials from the various financial management disciplines have been established per district to support municipalities throughout the six month period.

All municipalities are urged to co-operate and promptly respond to the above request as this pro-active approach will go a long way in improving the 2013/14 audit outcomes.
