SUBMISSION OF FIRST DRAFT OF BUDGET DOCUMENTS FOR 2018 MTEF PERIOD

In terms of Treasury Regulation 5.1, the Accounting Officer of an institution must prepare a plan that is consistent with the period covered by the Medium Term Expenditure Framework for approval by the Executive Authority.

All Votes are required to submit the following budget documents to Provincial Treasury:

- 1. Database
- 2. Estimates of Provincial Revenue and Expenditure

The following are the consumer price inflation (CPI) assumptions for the 2018 MTEF planning process:

- 1. 2018/19: 5.7 per cent
- 2. 2019/20: 5.6 per cent
- 3. 2020/21: 5.5 per cent

All Votes are requested to adhere to these indicative Consumer Price Index numbers in preparing the estimates but all Votes have to remain within their indicative figures (indicative figures as in the 2017 MTEF Estimates of Provincial Revenue and Expenditure).

Compensation of Employees

Current projections for cost of living and other adjustments to payroll remuneration are:

The cost-of-living adjustment in 2017/18 is 7.3% and will be followed by the projected CPI numbers indicated below for the next three years:

- 1. 5.7% (CPI + 1) in 2018/19
- 2. 5.6% (CPI + 1) in 2019/20
- 3. 5.5% (CPI + 1) in 2020/21

All Votes are required to comply with the Guideline on costing and budgeting for compensation of employees.

Documents required

The budget submission must be accompanied by a narrative letter signed by the Accounting Officer, which highlights important information taken into account in preparing the submission and to confirm that the budget documents have been fully completed. Other details required on the narrative letter are included in the 2018 MTEF Guidelines (MTEF Technical Guidelines).

Importantly, this letter by the Accounting Officer must also indicate that the relevant Executive Authority has agreed to information contained in the budget submission and has been appraised of the requirements of the 2018 Budget process.

You are requested to refer to the **2018 MTEF Guidelines** for comprehensive guidance on requirements on submission of complete budgets.



PROVINCIAL TREASURY CIRCULAR NO. 42 OF 2017

The explanatory narrative should include information in respect of the following, where relevant:

- 1. A summary of the rationale underlying any proposed significant movement of funding, as shown in the MTEC baseline adjustment workbook, that is in terms of:
 - o Input cost pressures,
 - o Higher priority,
 - o Legal requirement, and
 - o Cost containment and efficiency.

You are reminded that if a submission is submitted without an **explanatory narrative letter** it will be regarded as a non-submission.

The MTEC database will be forwarded to you electronically and can also be collected from your programme officer. The 2018 MTEF Guideline is attached for ease of reference and attention.

Departments that have Public Entities are required to submit similar documents for those Entities.

Submission date

All votes are requested to submit the **2018 MTEF budget documents** (Database and explanatory narrative) on or before **31 July 2017**.
