
1. The Provincial Treasury would like to invite officials who are responsible for compiling budget estimates and for capturing IYM data to a workshop to be held as follows:

 - Key changes on the database and problematic areas to improve the quality of documents
 - Areas that require improvement on the IYM data and reason for deviations and provide training on how to request BAS reports for IYM reporting
