**SUBJECT: INVITATION TO THE SUPPLY CHAIN MANAGEMENT FORUM FOR LOCAL GOVERNMENT ON NEW PREFERENTIAL PROCUREMENT REGULATIONS, 2011**

**1. PURPOSE**

- 1.1. This circular serves to invite all municipalities in the province for attendance to the Supply Chain Management Forum which is meant to inform municipalities about new developments regarding the new Preferential Procurement Regulations.
- 1.2. The forum is scheduled for Thursday, 24 November 2011 at Nkangala District Municipality in Middelburg (to be confirmed). The programme will start at 09:00 a.m. until 13:00 p.m.

**2. BACKGROUND**

- 2.1. The Preferential Procurement Regulations 2001, which were issued in terms of the Preferential Procurement Policy Framework Act 5 of 2000, have been associated with a number of challenges since their inception in 2001.
- 2.2. To remedy the situation, the National Treasury resolved that these regulations be repealed in order to give way to the new ones which will address the challenges.
- 2.3. To this effect, the Minister of Finance has approved the new Preferential Procurement Regulations which are intended to replace those that were promulgated in 2001.


**3. DELEGATION**
