# EXTENSION ON THE IMPLEMENTATION OF NATIONAL TRAVEL POLICY FRAMEWORK

## **PURPOSE**

The purpose of this Circular is to inform departments, constitutional institutions and public entities listed in schedule 3A and 3C to the Public Finance Management Act (PFMA), of the extension on the implementation of the National Travel Policy Framework.

### DISCUSSION

National Treasury Circular No.4 of 2016/17 that should be read in conjunction with Supply Chain Management Treasury Instruction 1 of 2016/17 which gives effect to the implementation of the National Travel Policy Framework with effect from 1 July 2016 has now been extended in order to allow stakeholders to provide feedback on the policy. The implementation date will be communicated to all organs of state once National Treasury has revised the policy.

Heads of Departments, Constitutional Institutions and Chief Executive Officers of Public Entities are requested to bring the contents of this Circular to officials within their institutions.
