SUBMISSION OF REVISED SUPPLY CHAIN MANAGEMENT (SCM) POLICIES ALIGNED WITH THE NEW PREFERENCIAL PROCUREMENT REGULATIONS 2017

PURPOSE

The purpose of this Circular is to request all Departments and Public Entities to submit revised Supply Chain Management Policies in line with the New Preferential Procurement Regulations 2017.

BACKGROUND

In terms of Section 38(1)(a)(iii) and 51(1)(iii) of the Public Finance Management Act, No. 1 of 1999 (PFMA), the accounting officer of a department or constitutional institution and the accounting authority of a public entity listed in Schedule 2 and 3 to the PFMA must ensure that their respective institution has and maintains an appropriate procurement and provisioning system which is fair, equitable, transparent, competitive and cost-effective.

In January 2017, new Preferential Procurement Regulations were gazetted in replacement of the Preferential Procurement Regulations of 2011, to replace the outdated procurement and provisioning practices across government with a Supply Chain Management (SCM) function that will be an integral part of financial management and will conform to best practices. The new arrangements will promote uniformity in SCM processes and also in the interpretation of Government's preferential procurement legislation and policies, which should be seen in the context of other related legislative and policy requirements. Above all, these provisions will mean that responsibility and accountability for SCM-related functions will be entrusted to accounting officers or accounting authorities.

Therefore, in terms of the legislative requirements, Supply Chain Management Units should align their policies to be in line with the applicable legislation as it impacts on supply chain management processes.

SUBMISSION DATE OF SCM REVISED POLICIES

Departments and Public Entities are requested to submit their revised SCM policies to Provincial Treasury by <u>31 August 2017</u>.

DISSEMINATION OF INFORMATION

Heads of Departments and Chief Executive Officers are requested to bring the contents of this Circular to the attention of the Chief Financial Officers and Heads of Supply Chain Management units for implementation in order to enhance compliance.
