## NOMINATIONS OF SUPER USERS FOR ETENDERS PUBLICATION PORTAL

## 1. PURPOSE

The purpose of this circular is to request all the Accounting Officers to nominate Super users for eTenders Publication Portal.

#### 2. BACKGROUND

In terms of section 38(1) (a) (iii) and 51 (1) (iii) of the PFMA, the accounting officer of a department or constitutional institution and accounting authority of a public entity listed in Schedule 2 and 3 to the PFMA must ensure that their respective institution have and maintains an appropriate procurement and provisioning system which is fair, equitable, transparent, competitive and cost effective.

In improving public sector procurement, National Treasury's Office of the Chief Procurement Officer (OCPO) identified the advertisement of bids and publication of awards as being key in achieving transparency in procurement and implemented the eTenders Publication portal.

## 3. DISCUSSION

National Treasury issued circular 1 of 2019/20 on the eTenders Publication Portal which indicated issues or challenges experienced on the current eTenders system. It is against this background that the Office of the Chief Procurement Officer (OCPO) has embarked on the re-development of eTenders website to improve system performance.

As their intention to bring efficiency on the system utilisation as part of the newly developed eTenders website. One of the areas of efficiency is introducing eTender Super User at each organ of state in order to eliminate dependency on OCPO for user account management and first line support.

The Super users will be responsible for the following:

- Account management i.e. new users on the system and password related queries, of which National Treasury will register Super users.
- First line support is basic support on system functionality .e.g. responding to queries related to capturing of procurement plans and upload them, creating and publishing tenders, uploading tender documents and contract register function.

There will be training arranged not only for Super users but all end users as the new eTenders system will have additional functionality National Treasury will communicate that with the relevant nominated end users once they've finalised the schedule.
