**INVITATION TO THE SUPPLY CHAIN MANAGEMENT SUMMIT “GOING BACK TO BASICS”**

**1. INTRODUCTION**

- 1.1. The purpose of this circular is to invite Heads of Department and Chief Executive Officers of Public Entities in the Mpumalanga Provincial Administration to the two-day summit on Supply Chain Management, which is aimed at forging unity and creating a supporting environment for Supply Chain Management amongst the public sector institutions. In addition, Heads of Department and Chief Executive Officers of Public Entities should be accompanied by their respective teams which should be made of Chief Financial Officers; SCM Managers and three additional SCM practitioners.

**2. BACKGROUND**

- Since the inception of procurement reforms in 1995, the public sector procurement environment has been characterized by a number of challenges which hamper service-delivery in our communities. In terms of the assessments conducted by the Provincial Treasury, the most prevalent challenge facing Government procurement is non-compliance with applicable legislative framework governing procurement.

- 3.1. It is trusted that this summit will bring about improvement on the implementation of Supply Chain Management to address the challenges mentioned above, through the involvement of the following stakeholders to make presentations:

- 3.2. In addition, the Supply Chain Management summit will focus more on governance, ethics and technical competency in Government.
