## EMPOWERMENT OF DESIGNATED GROUPS

### 1. INTRODUCTION

The purpose of this circular is to request Municipalities in the Mpumalanga province to submit information on the status of empowerment of the designated groups, as contemplated on Sub-Regulation 4 of the Preferential Procurement Regulations, 2017.

### 2. BACKGROUND

In terms of Sub-Regulation 4 of the Preferential Procurement Regulations 2017, organs of state may decide to apply pre-qualifying criteria to any project in order to advance certain designated groups. The Provincial Treasury would like to determine the extent to which organs of state applied the above-mentioned regulation in order to empower designated groups. To this end, the Provincial Treasury has developed a template (attached) which must be completed in full by Municipalities. The information will assist the Provincial Treasury in assessing progress made in the advancement of designated sectors. The information must cover the period 1 July 2020 to 30 June 2021.

### 3. PROVINCIAL TREASURY'S DIRECTIVE

Municipalities are requested to submit the information as captured on the attached template on or before Tuesday, 16 November 2021. Municipal Managers are requested to disseminate the contents of this circular to their respective units for implementation. The completed information should be signed off and submitted to:
