**INVITATION TO ATTEND A BRIEFING SESSION BY THE OFFICE OF THE CHIEF PROCUREMENT OFFICER (OCPO) ON SCM ICT REFORMS: LOCAL GOVERNMENT TASK TEAM INTRODUCTION**

- 1.1. This circular serves to invite Municipal Managers, Chief Financial Officers, Supply Chain Managers, Heads of Internal Audit and IT Managers of all municipalities in the Mpumalanga Province to attend a briefing session to share on SCM ICT initiatives that are undertaken by the OCPO as part of Public Sector SCM reforms.

Further the invitation is extended to Councillors who are part of the SALGA Finance Working group to be part of the Local Government SCM reform task team.

**2. BACKGROUND**

- 2.1. On 12 November 2014 Cabinet approved the proposed reforms and entrusted the Office of the Chief Procurement Officer (OCPO) with the responsibility to speed up SCM reforms by:
- Finalising the legal framework aligned to the proposed reforms;
  - Simplifying, standardising and automating procurement activities across all spheres of government;
  - Modernize SCM technology and up scaling the utilisation rate.

As part of Public Sector SCM ICT reforms strategy the OCPO has introduced the following three SCM ICT innovations which are:

- Central Supplier Database (CSD);
- E-tender and ;
- G-Commerce
