CAPACITY BUILDING COMMUNIQUE – SHORT COURSES FOR PUBLIC SECTOR INTERNAL AUDITORS ENDORSED BY NATIONAL TREASURY

- 1. There is a critical need to improve the competencies of Public Sector officials, particularly in the Public Financial Management (PFM) space. The need for building capacity has not only been identified by section 13 of the National Development Plan (NDP) 2030 "... building a capable and developmental state", but also by section 6(2)(d) of the PFMA, and various other reports, amongst others the iKutu and Auditor-General of South Arica reports. Section 34(1) of the MFMA on capacity building provides for the national and provincial government to assist municipalities in building the required capacity for efficient, effective and transparent financial management.
- 2. The Chief Directorate: Capacity Building within the National Treasury (NT) has worked with key stakeholders, the National School of Government (NSG), the Department of Public Service Administration (DPSA) and the Institute of Internal Auditors South Africa (IIA SA) to develop and/ adapt impactful short courses to address some of the capacity needs facing internal auditors in the public sector.
- National Treasury through the IIA SA has released public sector focused and workplace application-based short courses related to Internal Audit. The short courses target all three spheres of government.
- Kindly note that the Ethics in Public Service short course will be for free to all public sector internal auditors who sign up before 01 December 2018 and complete it before 31 March 2019.

Please see attached brochure with details of the course which is available on the NSG website www.thensg.gov.za under eLearning. Public Sector Internal Auditors' are advised to complete this course as it is a prerequisite for another short course specifically for Internal Auditors that will be available in April 2019. Details will be communicated closer to the time.

- National Treasury, together with NSG and DPSA, is embarking on the development of internal audit specific ethics micro lessons/ refreshers, as an addition to the initial online Ethics in Public Service course developed by NSG which forms part of the list of short courses for internal audit in Annexure A.
- 6. Further to the above, the IIA SA has made ethics training a compulsory component of the annual continued professional development (CPD) hours for all its members as from January 2018. Moreover, annual ethics CPD training will be a minimum of two (2) hours for CIA members and three (3) hours for IAT and GIA/ PIA⁵ members respectively.
- Please find all the information pertaining to the short courses developed which is available for consumption and on request. Refer Annexure A attached.
- 8. The Chief Directorate: Capacity building will continue on this trajectory and will update its stakeholders with more developments accordingly.
