**SUBMISSION OF OWN REVENUE TARIFFS: 2018/19 FINANCIAL YEAR**


In terms of Treasury Regulation 7.3.1, the Accounting Officer of an institution must review, at least annually when finalising the budget, all fees, charges or the rates, scales or tariffs of fees and charges that are not or cannot be fixed by any law and that relate to revenue accruing to a revenue fund. The Accounting Officer must obtain approval from the relevant treasury for the proposed tariff structure. Departments are also expected to inform Provincial Treasury if they will be maintaining the tariffs.

Departments are therefore reminded to start revising their tariffs and submit their proposals for the revision of tariffs for the 2018/19 financial year to the Provincial Treasury **on or before 13 October 2017**.
