The National Treasury has drafted a Public Sector Compliance Management Framework together with its related guidelines to assist all departments, Constitutional Institutions and Public Entities listed in Schedule 3A and 3C to the PFMA to improve their compliance with laws and regulations.

The Compliance Management Framework with other related guidelines was open for comments until June 2017, wherein National Treasury was in the process of incorporating comments and receiving inputs so as to finalise the framework and its guidelines.

National Treasury wishes to provide an information session to Chief Financial Officers, Chief Audit Executives and officials involved with internal controls in Departments and Public Entities in the Province.

The Provincial Treasury is therefore inviting all Chief Financial Officers, Chief Audit Executives and Officials involved with internal controls to a workshop where National Treasury will be presenting the final Compliance Management Framework and related guidelines.
