SUBJECT: INVITATION TO ATTEND SCM AND BID COMMITTEES WORKSHOP

1. PURPOSE

The purpose of this circular is to extend an invitation to Chief Financial Officers, Heads of Internal Audits, Chief Risk Officers, Heads of Supply Chain Management and Bid Committee members in Departments and Public Entities to the Supply Chain Management workshop to be conducted by National Treasury on the 11 - 12 March 2026.

2. DISCUSSION

Provincial Treasury, in line with its mandate, is responsible for monitoring and overseeing the implementation of supply chain management processes across Departments and Public Entities to ensure adherence to all applicable legislative and regulatory frameworks. In fulfilling this mandate and strengthening overall compliance and performance, the Provincial Treasury has partnered with the National Treasury and the Auditor-General to establish a platform that enables organs of state to share best practices and knowledge in SCM. This intervention is in support of the Provincial Treasury circular dated 05 December 2025, requesting organs of state to identify and submit pertinent supply chain management risk areas.

To this end, organs of state are invited to participate in the SCM and Bid Committee workshop, which is aimed at promoting effective, efficient and competitive governance within the procurement process. The National Treasury will be conducting the workshop as part of a support intervention to improve capacity within SCM practitioners and Bid Committee members on the implementation of effective SCM practices and compliance with applicable legislative and regulatory framework.
