SUBJECT: QUARTERLY REVIEW OF THE FINANCIAL RECOVERY PLAN IN TERMS OF SECTION 147 OF THE MUNICIPAL FINANCE MANAGEMENT ACT, NO 56 OF 2003

On 15 August 2023, the MEC for Finance in the Mpumalanga Province wrote to the Minister of Finance requesting a review and amendment of the existing mandatory financial recovery plans (FRP) for Thaba Chweu, Govan Mbeki, Msukaligwa and Emalahleni Local Municipalities in terms of Section 144 of the MFMA.

The request for a review and amendment of the FRP emanated from the failure of the existing FRP to achieve the desired financial turnaround and improve the provision of basic services in the municipality.

After following the required consultative processes, the Municipal Financial Recovery Services (MFRS) unit within the National Treasury prepared the amended FRP's, which were officially handed over to municipal Councils. This draft FRP was prepared in accordance with Section 144 of the MFMA read together with section 141 of the MFMA.

The amended version of the FRP has been designed to address the shortcomings in the current FRP's, which may to an extent, have prevented the attainment of the FRP objectives.

Section 147 of the MFMA requires the MEC for Local government and MEC for Finance to review a mandatory intervention in terms of Section 139 of the Municipal Finance Management Act 56 of 2003, including progress with resolving a municipality's financial problems and its financial recovery.
