#### 1. OBJECTIVE

The objective of this circular is to inform all participating Government Departments and Public Entities about the annual price increase awarded to Travel Agents under transversal tender MPPT 002/22/03

## 2. BACKGROUND

In terms of the service level agreement signed on the 1<sup>st</sup> of June 2023 with the 6 (six) following travel agents: annual price increases are granted in line with CPI.

- · City of Choice Travel and Tours
- Dana Agency
- ZAPG Travel and Tours
- Let's Cruize Travel
- Big Sky Country Trading
- Vakasha Travel



All annual price increases are guided by the signed service level agreement under Part D, special condition of contract as well as Annexure B

### 3. FINANCIAL IMPLICATION

With effect from 1 June 2025, a CPI price increase of 2.7% is granted for travel service fees as per attached table. The 2.7% is not applicable on percentages previously negotiated for:

- long stay booking
- conferencing
- corporate gifts/flowers
