SUBJECT: REQUEST FOR MUNICIPALITIES TO SUBMIT THEIR MONTHLY ORGANS OF STATE DEBTORS REPORT TO THE LOCAL GOVERNMENT DATABASE SYSTEM(GO MUNI) STARTING FROM APRIL 2025 GOING FORWARD

1. PURPOSE

To request for Municipalities to submit their monthly organs of state debtors reports to the Local Government Database System (Go Muni) starting from April 2025 going forward

2. BACKGROUND

The Mpumalanga Provincial Treasury has been assigned the responsibility to coordinate payment and settlement of the organs of state debt owed to municipalities in the Province. This task is given effect by section 64(3) of the Municipal Finance management Act no.56 of 2003 which read 'The accounting officer must immediately inform the National Treasury of any payment due by an organ of state to the municipality in respect of municipal tax or for municipal services, if such payments are regularly in arears for periods of more than 30 day"

3. DISCUSSION



PROVINCIAL TREASURY CIRCULAR NO. 7 OF 2025

Provincial Treasury developed a standard template in 2008 when the Provincial Government Debt Forum was established for municipalities to submit their monthly debt reports for consolidation and for coordination of payments from owing organs of state. It has been noted with great concern that the monthly debt reports contain figures that are not consistent from month to month; that there has been alleged non-allocation of payments made by organs of state, as well as other discrepancies identified in those reports since the template was developed.

Hence the credibility of the consolidated debt report is often questioned whenever it is presented to various committees including the MuniMec, Provincial Management Committee (PMC) and Provincial Excecutive Committee (EXCO).

It is against this background that the Provincial Treasury will no longer use the monthly debt report template from municipalities to consolidate the monthly organs of state debt report. Therefore, municipality are required to submit their monthly organs of state debtors report on local government database (Go Muni System) **starting from April 2025 going forward.** Meaning that municipalities are to submit their last monthly report templates for the period ending 31 March 2025 to Provincial Treasury.

Municipalities are to ensure that they submit their monthly reconciled reports to the said system in line with Section 71 of the MFMA, which is within the 10 working days after the end of each month. This will enable Provincial Treasury to coordinate payments based on accurate and correct figures, which are signed off by the Chief Financial Officer and the Accounting Officer.
