1. PURPOSE

The purpose of this circular is to invite Municipalities to the SCM awareness session to be conducted by National Treasury on Microsoft Teams on 06 March 2024.

2. DISCUSSION

National Treasury will be conducting awareness sessions to all three spheres of government on the initiated project to develop the Compliance Risk Assessment and Monitoring Plan which is aimed at improving the level of Supply Chain Management legislative compliance and guidelines and also assist in identifying and assessing high risk and high impact procurement matters in government. This initiative further aims to improve Supply Chain effectiveness and efficiency towards sustainable public financial management and improved service delivery. It will also promote compliance with SCM legislative framework as a result reduce the likelihood of irregular, fruitless and wasteful expenditure.
