In terms of Section 34 (1) of the Municipal Finance Management Act, the national and provincial governments must by agreement assist municipalities in building the capacity of municipalities for efficient, effective, and transparent financial management. Hence, the intervention by Provincial Treasury is to compliment the National Treasury to ensure that municipalities do comply with the requirements of this programme.

The Provincial Treasury has applied for a Discretionary Grant Funding with the Local Government Sector Education and Training Authority (LGSETA).



PROVINCIAL TREASURY CIRCULAR NO. 12 OF 2023

The Provincial Treasury in conjunction with National Treasury has supported municipalities through a number of capacity building initiatives to build sufficient strategic management capacity at the local government sphere.

One such capacity building initiative is the Municipal Finance Management Internship Programme in partnership with the Local Government Sector Training Authority (LGSETA).

It is envisaged that through workplace interaction with municipal officials and coaching by municipal managers, the learners will integrate formal training with workplace service-oriented activities.

The Provincial Treasury anticipates to recruit the learners by 20th of March 2023 on the following programme.

The learnership programmes as part of the training intervention are as follows:

- 1.1 Learnership - National Certificate: Municipal Financial Management Programme. SAQA ID: 48965
- 1.2 Learnership - National Certificate: Local Economic Development. SAQA ID: 67509
- 1.3 Learnership - National Certificate: Environmental Practice. SAQA ID: 49752

Provincial Treasury is the lead host employer responsible for the coordination and administration while the municipalities will be the host employer and mentorship and the programme will be funded by LGSETA.

It should be noted that the Provincial Treasury will enter into a Service Level Agreement with the Skills Development Providers (SDP).

Your Municipality is therefore requested to be the Host Employer and Mentor for the LGSETA Leaderships Programme.
