PREVENTATIVE ITEMS FOR THE CORONA VIRUS (COVID 19) IN THE MPUMALANGA PROVINCIAL GOVERNMENT

All Accounting Officers must take note that the National Treasury is facilitating the negotiations and bulk quotation process for essential preventative items for the corona virus (COVID-19) Disaster.

Departments and Public Entities must also note that the following items are available on Transversal Contracts as indicated below:

- Face masks and Disposable Aprons are available on RT32-2019
- Safety Goggles and PVC Boots are on RT64-2019
- Gloves are available on RT76-2020
- Sanitizers available on RT296 are only for surfaces and not for application on hands.
- For Items that are not on Transversal Contracts, the Office of the Chief Procurement Officer has already sought quotations on behalf of all State Institutions and are finalizing responses from the suppliers.

The final price list will be available on Wednesday 18 March 2020, to make it easier for institutions to procure these items from suppliers either through the Transversal Contracts or through the quotations that National Treasury would have negotiated.

This will limit the buying through the emergency procurement procedures as well as rogue and panic buying.
