1. INTRODUCTION

The purpose of this circular is to request Departments and Public Entities in the Mpumalanga province to submit information on the status of procurement spend in the Mpumalanga province in addressing the specific goals as contemplated in section 2 (1)(d) of the Act which may include contracting with persons, or categories of persons, historically disadvantaged by unfair discrimination on the basis of race, gender and disability including the implementation programmes of the Reconstruction and Development Programme as published in the Government Gazette No.16085 dated November 1994.

2. BACKGROUND

The Honourable Premier Refilwe Mtsweni – Tsipane in her address on 24 February 2023 made a pronouncement that the Mpumalanga Provincial Government will use the public procurement system to promote economic participation in order to transform the ownership of the means of production. In this regard, thirty percent of the provincial targeted government spend shall be for enterprises owned by women, youth and people with disabilities.

To this end, the Provincial Treasury has developed a template (attached) which must be completed in full by Departments and Public Entities. The information will assist the Provincial Treasury in monitoring the implementation of this procurement spend to achieve the specific goals as outlined in the Reconstruction and Development Programme and support the insitutions to effectively manage the procurement of goods and services in the Mpumalanga Province. The information must cover the period 1 January – 31 March 2023 and thereafter on a monthly basis on or before the 7th following the end of the month.

3. PROVINCIAL TREASURY'S DIRECTIVE

Departments and Public Entities are requested to submit the information as captured on the attached template on or before Thursday, 25 May 2023. Heads of Department and Chief Executive Officers of the Public Entities are requested to dessiminate the contents of this circular to their respective units for implementation.
