## SUBMISSION OF FIRST DRAFT OF BUDGET DOCUMENTS FOR 2020 MTEF PERIOD

In terms of Treasury Regulation 5.1, the Accounting Officer of an institution must prepare a plan that is consistent with the period covered by the Medium Term Expenditure Framework for approval by the executive authority.

The following policy guidance should be taken into account when preparing the budget submission:

There are **NO** additional resources available for allocation over the 2020 Medium Term Expenditure Framework (MTEF) period within the expenditure ceiling set in the 2019 Budget. This means that additional allocations to a programme will need to be funded through reductions of funds in another programme. This may involve the scaling down of non-priority programmes and projects, changing service delivery models, using technology more effectively, etc.

All votes are required to submit a database to Provincial Treasury, a scenario reflecting a 5 percent; 6 percent and 7 percent reduction over 2020 MTEF period. This should be accompanied by a comprehensive narrative report providing details of where cuts were made and the impact thereof.

This is also applicable to Public Entities and should be submitted on the set date.

The following is a table that reflect estimated amounts to be reduced from departments based on the percentage deduction over MTEF period.
