PROVINCIAL TREASURY CIRCULAR NO. 43 OF 2023

RE: SUBMISSION OF mSCOA ROAD MAPS

The mSCOA regulations was promulgated on 22 April 2014 prescribed not only a standardised financial classification for municipalities but also a new era in planning, budgeting, transacting and reporting for Local government.

At this stage municipalities should be ensuring that they fully comply with the current minimum business processes and system specifications as required in MFMA Circular No.80.

Where a municipality is not fully compliant with the mSCOA requirements, an mSCOA Road Map must be developed to drive and fast track the mSCOA implementation in the municipality. The mSCOA Steering Committee must use the mSCOA Road Map to track progress and take corrective actions where required.

It is against this background that Road Maps must be reviewed annually and submitted to Council for approval together with the 2023/24 MTREF budget. Furthermore, municipalities are required to submit the updated mSCOA Road Map in a PDF format on the GoMuni upload portal as part of the tabled and adopted budget submission and thereafter report progress on a quarterly basis as part of the in-year reporting.

To this end none of the Municipalities in the Province have uploaded the mSCOA Road Map on the GoMuni upload portal.

Your municipality is therefore requested to ensure that:

- a) The mSCOA Road Map is adopted by Council
- b) Uploaded to GoMuni by no later than 04 August 2023
- c) Progress on implementation be reported on a quarterly basis

Your co-operation in this regard is appreciated.
