2. There are two phases to the project, the first being the collection of organisational information and the second being an individual survey. In order to ensure a streamlined and efficient process, kindly note that NT will be conversing directly with Chief Audit Executives and their staff. All Internal Audit functions based in local government are to participate in the survey.
3. The results of the baseline study will inform the development of responsive and appropriate capacity building initiatives and solutions, thus creating an enabling environment for municipalities to direct their already limited resources to areas that would best promote and enhance their mandate and strategy. The results will further focus on fit-for-purpose solutions, with emphasis on the enhancement of existing training and development models and support programs, with the aim of advancing staff morale and operational performance.
4. It would be appreciated if each Provincial Treasury in partnership with the NT could assist in providing support to this process by disseminating the content of this communication to all municipal managers of municipalities and collating the information within its jurisdiction; including conducting advocacy work and ensuring that the baseline study survey is completed by each municipality.
5. Due to the size, nature and extent of this project, the NT will be monitoring the progress of this process and will liaise and follow-up where necessary, directly with provincial treasuries and or municipalities on any outstanding or inconsistent surveys during the information collection process. The National Treasury will also be responsible for the analysis of survey information.
6. The information gathered will be used to inform capacity development initiatives to aid in building competencies that will augment Internal Audit in the public sector.
7. Head Officials of Provincial Treasuries are kindly requested to bring the contents of this communicate to the attention of municipal managers of municipalities in their respective provinces.
