## PROVINCIAL TREASURY CIRCULAR NO. 77 OF 2020

## **DISCONTINUATION OF CHEQUES WITH EFFECT FROM 1 JANUARY 2021**

This Circular seeks to advise Provincial Departments about the banks' decision to discontinue utilization of cheques effective from 1 January 2021.

The discontinuation will have an effect as cheques are a means of payment or receivables in various cash offices and directly deposited in the bank, petty cash as well as salary cheques where necessary for issues such as personnel verification.

The bank has provided pay-card as alternatives for cheques. The pay-card is allocated to a user with a pin-code and can be loaded to a maximum amount of R 25,000.00 and can be utilized for purchases at retail stores as well as for cash withdrawals to a maximum amount of R 5,000.00 per day. Departments that have clients that use cheques for payments are advised to inform them accordingly.

The Departments will be able to access the funds in the following manner;

- 1. By using pay cards linked to a sub-account of the respective department, the cards would be issued in the department's name and the department will then issue the card to the (regions or offices) individual appointed for petty cash administration.
- 2. The cards transactions are restricted to withdrawal through the teller or ATM. Online transactions are not activated on the cards.
- 3. Direct electronic transfer to be utilized for salary payments when necessary.

You are further advised that Provincial Treasury, in support of implementing the process, will arrange training for relevant officials as soon as possible. The Provincial Treasury is in support of the change and has already benchmarked with other Government Institutions including National Treasury.
