To address all findings as raised by AGSA, it is advisable that Municipalities develop the audit action plans using the summary of detailed audit findings and ensure that all fields in the web enabled audit action plan are completed with accurate and relevant information. All Municipalities must ensure that, the audit action plan on the web enabled system is finalised by 30 December 2024.

Municipalities are further advised to ensure that regular updates are done on the system to reflect the actual progress that has been made towards addressing the audit findings. Provincial Treasury will continuously monitor the progress implementation of corrective actions.
