**SUBJECT: REQUEST FOR SUBMISSION OF REVENUE ENHANCEMENT STRATEGIES**

### 1. PURPOSE

Given the current economic and fiscal constraints affecting the province, Provincial Departments and Entities are expected to grow and maximize their revenue collection to augment the allocations from the National Treasury. Provincial Treasury has noted the presentations on the revenue enhancement strategy by Provincial Departments and Entities during the MTEC hearings held on 22, 24, and 25 October 2024.

Provincial Treasury observes that the revenue enhancement strategies should be in a format that outlines the focus area, the return on investment whether monetary or otherwise, and the time frames. The Provincial Treasury has a renewed focus on supporting provincial Departments and Entities by all means to expand their revenue base. This can only be achieved through investment in a revenue enhancement strategy. This call was amplified by an EXCO resolution to support the need to develop a consolidated revenue enhancement strategy to maximize collection.

It is in this context that the revenue enhancement strategies are aligned to budget processes for consideration by the Provincial Treasury, therefore the Departments and Public Entities are requested to submit a cost-benefit revenue enhancement strategy. **The due date for submission is 22 November 2024.**
