SUBJECT: INVITATION TO THE PROVINCIAL GOVERNMENT DEBT FORUM

1. PURPOSE

To invite the Municipalities, Sector Departments and Other Organs of State to the Provincial Government Debt Forum Meeting.

2. BACKGROUND

Section 64(3) of the Municipal Finance Management Act requires the Accounting Officer of a Municipality to notify the Provincial and National Treasury of any payments due by an organ of state in respect of municipal taxes or for municipal services, if such payments are due for more than 30 days. The Provincial Treasury has been assigned the responsibility to coordinate and consolidate monthly government debt reports for debt owed to municipalities by Sector Departments and Other Organs of State. Therefore, Provincial Treasury has established a Provincial Government Debt Forum that is convened on quarterly basis in an effort to recover monies owed by sector departments and reduce the debt owed to municipalities.

3. DISCUSSION

The Provincial Treasury is hereby inviting your Municipality/Department to the Provincial Government Debt Forum meeting. The forum intends to effectively deal with debts owed by Sector Departments to municipalities in the Province.
